Medical social workers enhances healthcare delivery and health equity and social justice (Bharadwaj & Koujalgi, 2024). Medical social work is viewed as one of the most significant fields in practice. It has been acknowledged as the first subspecialty discipline to practice in hospital, public health, and clinical settings (Allen & Spitzer, 2016). The overall goal of social work in healthcare is to prevent and reduce negative social and psychosocial consequences of diseases and to encourage and teach patients how to use their own resources (Sverker *et al.*, 2017).

Generally, the role of medical social workers has increasingly gain a recognition worldwide for their contribution towards comprehensive and quality health care delivery particularly in hospital settings (Bharadwaj & Koujalgi, 2024). Medical social workers perform their roles in hospital settings through the use of multidisciplinary approach which has proven to be an effective part of healthcare treatments. A multidisciplinary team is defined as a group of professionals that specialize in different disciplines that come together to deliver quality health care that addresses the patient's well-being (Allen & Spitzer, 2016). Using this approach allows the team to provide better-quality outcomes and to enhance client satisfaction; a team may be comprised of members from the same disciplinary background. A study conducted by Tadic *et al.*, (2020) reveals that medical social workers within an interprofessional healthcare teams are commonly involved in direct, one-on-one patient service delivery, including psychosocial services, primary mental healthcare services, prevention and health promotion, liaison with other organizations, counseling and home visits services, end of life/palliative care services, educating patients and they influenced the programs offered at the practice level. Medical social workers conduct psychosocial assessment within a multidisciplinary teams in a hospital to identify psychosocial needs of a patients to inform patients treatment plan (Birudu & Reddy, 2018).

The Role of Patients Advocate and Support

Advocacy is a cornerstone of social work, aiming to uplift marginalized groups and address systemic injustices (University of North Dakota, 2024). Medical social workers advocates for patients' rights and needs ensuring ethical treatment and transparency in healthcare delivery (Bharadwaj & Koujalgi, 2024). Moreover, medical social workers provide emotional support and counseling, particularly in complex cases such as elder mistreatment (Elman et al., 2024). Furthermore, advocating patients' rights and needs promote health equity and addresses social determinants of health (Desrosiers et al., 2016). The advantage of providing emotional support is that it helps patients to adapt to their health conditions, significantly improving their quality of life (Dosari et al., 2020).

Resources Mobilization

medical social workers connects patients with available community resources ensuaring they receive necessary services and support (Musuguri & Makuu, 2024). Foristance, assisting patients in accessing financial aids, transportation and support services (AL Dosari et al., 2020), providing education to individuals and families about the available resources and empowering patients to utilize these resources effectively (Musuguri & Makuu, 2024). Furthermore, medical social workers play a critical role in linking healthcare systems with community resources which is vital for comprehensive care (Shrivastava et al., 2014).

The Role of Discharge Planning

Medical social workers are responsible for discharge planners within healthcare settings when working within a multidisciplinary teams fostering smooth transition from the hospital to patients home settings. Their responsibilities including conducting a comprehensive assessments to identify patients emotional, social and practical needs ensuring that discharge plan goes together with individuals circumstances (Balaž Gilja, 2023). The comprehensive assessments also includes evaluation of the social contexts of the patients which

is critical for effective care coordination post-discharge (Szalados, 2021). The discharging process has to be done in a collaborative way where by social workers helps to integrate health, medical and welfare services to support patients in the community (Lee & Sung, 2022). Furthermore, medical social workers addresses barriers and ethical dilemmas to discharge such as lack of social supports or health complications which may delay the process (Heenan, 2023).

Inter-professional collaboration in chronic diseases management within a team. Medical social workers collaborate with staff to create comprehensive care plan to improves patients treatment outcomes (Musuguri & Makuu, 2024). Within the multidisciplinary team in the process of management of diseases like diabetes and depression their role is vital for addressing social determinants of health facilitating accessibility to necessary services (Bharadwaj & Koujalgi, 2024). However, the literature suggest such as lack of clear understanding of among healthcare practitioners regarding the full scope of social work hinder effective collaboration (Musuguri & Makuu, 2024). The article asserts that, this requires ongoing education and awareness to recognize the contribution of medical social workers in healthcare settings. As recognition will enhances communication and coordination among healthcare providers (McLaughlin Davis & Morley, 2022).

CONCLUSION

This article reveals the vital roles of medical social workers within multidisciplinary teams in hospital settings, highlighting their crucial contribution to patients care and healthcare delivery.
